

**Texas Title Insurance Guaranty Association
Guaranty Fee Third Quarter 2013 Report**

The Association received and deposited \$642,106 allocated to the third quarter of 2013. This sum represents approximately 321,053 policies. See the history of the collections in the Table entitled, “Guaranty Fee Policies by Quarters” on the next page.

On September 30, 2013, there were 572 licensed agents, a decrease of one (1) from the previous quarter. During the third quarter, six (6) agents’ licenses were cancelled, revoked, or suspended. We received remittances from 576 agents—16 remittances were late. There were two (2) agents who did not remit for unknown reasons.

As always, a late notice is sent to all late remitting agents reminding them of the due date. A notice is sent to all agents who fail to remit. All information concerning both groups of agents is forwarded to the Texas Department of Insurance (“TDI”) for further action.
